This License is non-exclusive and non-transferable, issued specifically for the Licensee, Licensee's Site locations and Workstation listed above. Any changes in circumstances that materially affect this License must be reported immediately to Blastwave FX.

RENEWAL: This License Agreement will automatically renew on the stated renewal date, for the same term and with the same conditions unless Blastwave FX is notified of any changes at least 30 business days prior to the renewal date. Licensee warrants that it will notify Blastwave FX of any changes to this license on a timely basis.

RESTRICTIONS: Licensee is not authorized to sell or make available unsynchronized sounds effects or music tracks via the Internet, or by any other means, from Blastwave FX products or products represented by Blastwave FX. Licensee is not permitted to copy or re-record

Nothing herein shall be construed as restricting Blastwave FX' right to sell, and on a non-exclusive basis, license, modify, publish or otherwise distribute its products, in whole or in part, to any other person or entity.
